

DALIMAR INSTRUMENTS
TERMS AND CONDITIONS OF SALE

Each quote issued by Dalimar Instruments ("Dalimar") and the acceptance of any purchase order by Dalimar for Dalimar products shall be governed by the following Terms and Conditions. Any order accepted by Dalimar shall be referred to herein as the "purchase order".

1. **GOVERNING TERMS AND CONDITIONS.** EXCEPT FOR AN ORDER WHICH SPECIFIES ONLY QUANTITY AND REQUESTED DELIVERY TERMS AND IS PART OF AN ACCEPTED ORDER, NO OTHER TERM WHICH DIFFERS FROM OR ADDS TO THESE TERMS AND CONDITIONS SHALL BE BINDING UPON SELLER. ANY OTHER OR DIFFERENT TERMS AND CONDITIONS PROPOSED BY BUYER ARE HEREBY EXPRESSLY REJECTED. THE PLACEMENT BY BUYER OF ANY ORDER SHALL CONSTITUTE ACCEPTANCE OF THESE TERMS AND CONDITIONS.

2. **TITLE, DELIVERY AND INSPECTION.** Products shall be delivered FCA (Incoterms 2010) Dalimar's facility, Quebec, Canada, unless otherwise agreed in a writing signed by Dalimar. Title and liability for loss or damage shall pass to Buyer upon tender of goods to common carrier for shipment to Buyer. Shipping dates are approximate only. Dalimar shall not be liable for any costs or damages (incidental, consequential, special or otherwise) for Dalimar's failure to meet delivery dates. Delays experienced by Dalimar in obtaining a validated export license shall be deemed excusable and beyond the reasonable control of Dalimar. Buyer shall have a reasonable time, not to exceed thirty (30) days to inspect goods delivered and to notify Dalimar of any discrepancies. Failure of Buyer to give notice under these terms shall be deemed acceptance of the applicable goods. Buyer agrees that all products provided under a purchase order shall be extensively tested prior to any end use to ensure that the products meet Buyer's requirements and application.

3. **PAYMENT TERMS.** All payments shall be made in Canadian funds. Dalimar may extend or withhold credit to Buyer in Dalimar's sole discretion. Where credit is extended to Buyer, terms of payment shall be net thirty (30) days from date of invoice. Credit may be withdrawn on subsequent shipments held by Dalimar at any time for late payment. Buyer shall pay interest at the rate of 1.5% per month from date of invoice for late payment.

Dalimar's prices are exclusive of all taxes and duties. Without limitation of the foregoing, responsibility for all customs duties and charges, sales taxes, use taxes, value-added taxes and any other taxes imposed by any federal, state, local or municipal taxing authority (excluding any taxes solely on Dalimar's income), shall be borne solely by Buyer. Additionally, Dalimar reserves the right, by giving notice to Buyer at any time before delivery, to increase the price of any product, due to a change in costs of manufacture or supply, including tariffs applicable to our import of such product or its components.

4. **TOTAL CUSTOMER SATISFACTION / LIFETIME WARRANTY PLUS / LIMITED WARRANTIES.**

A. **Total Customer Satisfaction.** Dalimar guarantees Total Customer Satisfaction through its "Lifetime Warranty Plus" on all Platinum Stock Products sold by Dalimar and through its Limited Warranties on all other Dalimar Stock, Standard and Special products.

B. **Platinum Stock Products - Lifetime Warranty Plus.** Under Dalimar's Lifetime Warranty Plus, if any Dalimar Platinum Stock Product ever fails, Dalimar will repair, replace or exchange the product at no charge. As a further benefit under Dalimar's Lifetime Warranty Plus, Dalimar will, for a one (1) year period following the delivery date of any Dalimar Platinum Stock product, refund 100% of the customer's purchase price paid for any such Product with which the original purchaser is not completely satisfied. This option of a refund may be selected in lieu of the repair, replacement or exchange of the product. "Platinum Stock Product" is defined as any Dalimar Stock Product designated by Dalimar from time-to-time as a "Platinum" model.

C. **Stock Products – Limited Warranty.** Dalimar warrants that all Dalimar Stock Products, other than Series 130, 377, 378, 426 and PCB Larson Davis Division Series 2500 Stock Product microphones, will be free from defects in materials and workmanship for a period of two (2) years from the date of original purchase. If any Stock Product shall fail during the warranty period, Dalimar will repair, replace or exchange it without charge. As a further benefit under Dalimar's Limited Warranty for Stock Products, Dalimar will, for a (1) year period following the delivery date of any Dalimar Stock Product, refund 100% of the customer's purchase price for any Dalimar Stock Product with which the original purchaser is not completely satisfied. "Stock Product" is defined to mean any product designated by Dalimar from time-to-time as a "Stock Product". This is generally a product on which Dalimar customarily maintains finished goods inventory.

D. **Microphone Stock Products – Limited Warranty.** Dalimar warrants that all Series 130, 377, 378, 426 and PCB Larson Davis Division Series 2500 Stock Product microphones shall be free from defects in materials and workmanship for a period of five (5) years from the date of original purchase. If any

such microphone shall fail during the warranty period, Dalimar will repair, replace or exchange it without charge. As a further benefit under Dalimar's Limited Warranty for Series 130, 377, 378, 426 and PCB Larson Davis Division Series 2500 Stock Product microphones, Dalimar will, for a (1) year period following the delivery date of any such microphone, refund 100% of the customer's purchase price for any such microphone with which the original purchaser is not completely satisfied.

E. **Standard Products, Special Products and Test and Measurement Cables – Limited Warranty.** Dalimar warrants that all Dalimar Standards, Dalimar Specials and test and measurement cables will be free from defects in materials and workmanship for a period of one (1) year from the date of original purchase. If any Dalimar Standard or Dalimar Special shall fail during the warranty period, Dalimar will repair, replace or exchange it without charge. "Dalimar Standard" is a product regularly manufactured by Dalimar for which Dalimar does not customarily maintain finished goods inventory. "Dalimar Special" is defined as any customized or modified Dalimar product for which Dalimar does not customarily maintain finished goods inventory, or any other product Dalimar classifies as a special from time to time.

F. **Services Warranty.** Services are warranted to be in a workmanlike manner for a period of ninety (90) days after performance. Dalimar's entire liability and customer's exclusive remedy, whether in contract, tort or otherwise for any claim related to or arising out of the breach of warranty covering Services will be re-performance or credit, at Dalimar's option.

G. **Shipping Charges.** Dalimar will, upon its receipt of any product under warranty, pay all shipping charges to send the repaired, replaced or exchanged product to the original point of shipment.

H. **Products Manufactured by Others.** Products manufactured by others are subject to the warranty, if any, of their respective manufacturers, and are to be repaired only by a respective authorized service person for such products. Dalimar shall have no obligation to undertake repairs of products manufactured by others.

I. **Applicability.** The Lifetime Warranty Plus applies to eligible Platinum Stock Products sold by Dalimar from time-to-time. The designation of a product as a Dalimar Platinum Stock Product, a Dalimar Stock Product, a Dalimar Standard or a Dalimar Special is based upon Dalimar's product classification, as determined in its sole discretion, at the time of the sale. If you have any questions regarding the classification of a product, please contact Dalimar for clarification. The warranties described above do not apply to Larson Davis products, products manufactured by third parties, products for which necessary components are no longer available on a commercially reasonable basis, or any Dalimar products damaged by accident, abuse, misuse, natural disaster or by any unauthorized disassembly, repair or modification. If there are any questions regarding power, intended application, or general usage of any Dalimar product, please consult with your local sales contact or distributor.

J. **No Extension of Statute of Limitations.** Any repairs performed under Dalimar's warranties shall not in any way extend the statute of limitations for claims under such warranties.

K. **WAIVER OF OTHER WARRANTIES. THE EXPRESS WARRANTIES SET FORTH IN THIS LIMITED WARRANTY ARE IN LIEU OF AND EXCLUDE ANY AND ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF INFRINGEMENT, MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.**

L. **Procedure for Warranty Performance.** For any warranty claim, the Buyer must provide Dalimar with the applicable model and serial numbers, the date of purchase, and the nature of the problem. Dalimar, in its discretion, may also require that the Buyer return to Dalimar the product being covered under warranty.

M. **Authority to Alter This Warranty.** No agent, representative, reseller, or distributor of Dalimar has any authority to alter the terms of this Limited Warranty in any way. This Limited Warranty may be altered only in writing by an authorized officer of Dalimar.

5. LIMITATIONS OF LIABILITY

A. **NO INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES. DALIMAR'S SOLE OBLIGATIONS UNDER ITS LIMITED WARRANTY ARE SET FORTH ABOVE IN PARAGRAPHS A THROUGH G. IN NO EVENT SHALL DALIMAR BE LIABLE TO THE BUYER OR ANY OTHER PERSON FOR ANY INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL, OR LOST PROFITS LOSSES OR DAMAGES OR FOR ANY FINANCIAL OR ECONOMIC LOSS CONNECTED WITH THE USE OF THE PRODUCT ORDERED UNDER THESE TERMS AND CONDITIONS. SUCH DAMAGES FOR WHICH DALIMAR SHALL NOT BE RESPONSIBLE INCLUDE, BUT ARE NOT LIMITED TO, LOST TIME AND CONVENIENCE, LOSS OF USE OF THE PRODUCT, THE COST OF A PRODUCT RENTAL, COSTS OF GASOLINE, TELEPHONE,**

TRAVEL OR LODGING, THE LOSS OF PERSONAL OR COMMERCIAL PROPERTY, LOSS OF CONTRACTS, LOSS OF PRODUCTION, AND THE LOSS OF REVENUE.

B. NO LIABILITY IN EXCESS OF PURCHASE PRICE. IN NO EVENT SHALL DALIMAR'S AGGREGATE LIABILITY WITH RESPECT TO ANY PRODUCT SOLD EXCEED THE PURCHASE PRICE OF SUCH PRODUCT PLUS ANY SHIPPING CHARGES THAT DALIMAR MAY BE OBLIGATED TO PAY PURSUANT TO PARAGRAPH G ABOVE. THE REMEDIES OF THE BUYER UNDER THESE TERMS AND CONDITIONS SHALL BE EXCLUSIVE AND IN LIEU OF ANY OTHER REMEDY AT LAW OR IN EQUITY.

6. **EXPORT CONTROL.** All Dalimar quotes and all Buyer purchase orders issued for Dalimar products are subject to all U.S. Export Regulations, including, without limitation, the International Traffic in Arms Regulations (ITAR) administered by the U.S. Department of State's Directorate of Defense Trade Controls, and the Export Administration Regulations (EAR) administered by the Department of Commerce's Bureau of Industry and Security. Dalimar's performance on any resulting sale or contract is contingent on strict compliance with these regulations as applicable and may require prior written approval from the U.S. Government (USG) before Dalimar can execute the terms and conditions of the purchase order. Dalimar shall not be liable for delays resulting from the actions or inaction of any USG agency.

Buyer agrees to comply with the terms and conditions of all applicable export and re-export regulations, and government written approvals related to this purchase order. Buyer agrees to indemnify and hold harmless Dalimar for all claims, losses, or damages, including, without limitation, reasonable attorneys' fees and expenses, incurred by Dalimar as a result of any failure by Buyer to comply with this Section 6.

7. **RIGHTS IN PROPERTY.** Buyer acknowledges and agrees that all right, title and interest in and to all writings, works of authorship, technology, inventions, discoveries, processes, techniques, methods, results of non-recurring engineering services, designs, validation studies, procurement information, bills of material, concepts, research, materials and all other work product of any nature whatsoever, that are created, prepared, produced, authored, edited, amended, conceived or reduced to practice by the Dalimar individually or jointly with others pursuant to this purchase order or related in any way to the business or contemplated business, products, activities, research or development of Dalimar or result from any work performed by Dalimar for the Buyer (in each case, regardless of when or where the work product is prepared or whose equipment or other resources is used in preparing the same), all rights and claims related to the foregoing, and all printed, physical and electronic copies and other tangible embodiments thereof ("Work Product"), as well as any intellectual property rights therein and all improvements thereto shall be the sole and exclusive property of Dalimar. The Buyer acknowledges that, to the extent permitted by law, all Work Product consisting of copyrightable subject matter is "work made for hire" as defined in the Copyright Act of 1976 (17 U.S.C. § 101), and such copyrights are therefore owned by Dalimar. To the extent that the foregoing does not apply, the Buyer hereby irrevocably assigns to Dalimar, and its successors and assigns, for no additional consideration, the Buyer's entire right, title and interest in and to all Work Product and intellectual property rights therein, including, without limitation, the right to sue, counterclaim and recover for all past, present and future infringement, misappropriation or dilution thereof, and all rights corresponding thereto throughout the world. Nothing contained herein shall be construed to reduce or limit Dalimar's right, title or interest in any Work Product or intellectual property rights so as to be less in any respect than Dalimar would have had in the absence herein.

8. **COMPLIANCE WITH LAWS.** Buyer represents and covenants that, at all times, Buyer's use, sale, marketing and export of all Dalimar products shall be in accordance with all applicable laws, rules, and regulations of the United States and of any other applicable jurisdictions, including without limitation, the U.S. Foreign Corrupt Practices Act and all applicable export laws, restrictions and regulations of the United States or any applicable foreign government, agency or authority. Buyer will not export or re-export, or authorize the export or re-export of any Dalimar product, technology or information it obtains or learns from Dalimar in violation of any laws, restrictions or regulations.

9. **APPLICABLE LAW.** The validity, performance and construction of this contract shall be governed by the laws of the Province of Quebec, Canada, without regard to principles of conflicts of law.

THE RIGHTS AND OBLIGATIONS OF THE PARTIES WITH RESPECT TO THIS QUOTE AND ANY PURCHASE ORDER ISSUED FOR DALIMAR PRODUCTS SHALL NOT BE GOVERNED BY THE PROVISIONS OF THE 1980 UNITED NATIONS CONVENTION ON CONTRACTS FOR THE INTERNATIONAL SALE OF GOODS.

10. **CANCELLATION.** Accepted orders may be cancelled subject to the provisions of this Section 11. Any order for a Dalimar Platinum Stock Product or a Dalimar Stock Product may be cancelled without penalty. In the event of a customer cancellation of a Dalimar Standard or Dalimar Special, Dalimar shall have the right to charge a cancellation fee equal to fifty percent (50%) of the purchase price payable with respect to the cancelled order. Such cancellation fee is intended to reimburse Dalimar for its costs incurred in preparing to meet Buyer's requested delivery schedule for a Dalimar Standard or Dalimar Special, including, without

limitation, Dalimar's commitments to its suppliers, and the cost of non-stock inventory (raw materials, work-in-process and finished products) allocated to Buyer's order together with an allowance for termination costs.

11. **SEVERABILITY**. If any term, provision, covenant or condition of this contract is held to be invalid, void or unenforceable by a court of competent jurisdiction, the remainder of this contract shall remain in full force and effect and shall in no way be affected, impaired or invalidated.

12. **NONWAIVER OF DEFAULT**. Each shipment hereunder shall be considered a separate transaction. In the event of any default by Buyer, Dalimar may decline to make further shipments. If Dalimar elects to continue to make shipments, Dalimar's actions shall not constitute a waiver of any default by Buyer or in any way affect Dalimar's legal remedies for any such default.

13. **ASSIGNMENT**. This contract shall not be assigned by Buyer without the prior written consent of Dalimar. If consent is given, this contract shall be binding upon and inure to the benefit of the assigns.

14. **ENTIRE AGREEMENT**. THIS CONTRACT CONSTITUTES THE ENTIRE AGREEMENT BETWEEN THE PARTIES RELATING TO THE SALE OF GOODS DESCRIBED HEREIN AND SUPERSEDES ALL PREVIOUS COMMUNICATIONS, REPRESENTATIONS OR AGREEMENTS, EITHER ORAL OR WRITTEN. THIS AGREEMENT MAY BE CHANGED ONLY BY A MODIFICATION, IN WRITING, SIGNED BY THE BUYER AND A DULY AUTHORIZED DALIMAR REPRESENTATIVE. NO COURSE OF DEALING OR TRADE PRACTICE SHALL ACT TO MODIFY OR INTERPRET ANY TERMS EXPRESSED IN THIS AGREEMENT.
